<i>Scope / Objective of the scheme including major interventions</i>	<p>The said Community Development units would be for vocational trainings, training of women in health, nutrition and child health, would be a place wherein local community could gather and socially interact.</p> <p>The physical scope include construction of a purposefully designed buildings whereas the required plots are available, free of cost. The building contains the provision for training classes, library, Computer room, Common hall / Multipurpose hall, offices etc. The required equipment / furniture include teaching tools, computers, books for library, Multimedia / sound system etc.</p>

**Decision**

- (i) The scheme was approved.
- (ii) Model Community Development Centers may be developed i-e one in urban area and the other in the rural surroundings in the initial phase.
- (iii) The scheme would be included in the next years ADP i-e 2009-10.
- (iv) In the light of above deliberations and decision taken, the PC-I would be expeditiously modified by Social Welfare Department in mutual consultation with Planning & Development Department.
- (v) On receipt and scrutiny of the modified PC-I, advice for administrative approval would be issued accordingly.
